3. Have you not in your hands, on deposit or under control, not exempt by law from seizure, any money, rights, credits, commissions, property, or effects of any description belonging to defendant herein? If yea, state what it consists of and how much.
4. Have you not since the service of these Interrogatories, paid or transferred to the defendant herein money, property, credits or effects of any description whatever or caused the same to be done, or had any transaction whatever with defendant? If yea, state in what it consisted.
5. State whether or not there are other judgments or garnishments affecting such wage, salary or compensation and if so the status thereof.
